With the subject cited above, the University Grants Commission (vide ref. 1), has instructed to implement anti ragging measures in all constituent and affiliated colleges of the University. Again University Grants Commission (vide ref. 2), has reiterated to inform all the colleges under the university. Therefore, in continuation of the circulars (vide ref. 3, 4), and in accordance with (ref.2), the following points are reiterated for strict implementation of ant-ragging measures:

1. University Grants Commission, New Delhi has framed regulations on curbing the menace of ragging in higher educational institutions in order to prohibit, prevent and eliminate the scourge of ragging.
2. These regulations are mandatory and all institutions are required to take necessary steps for implementation in totoincluding the monitoring mechanisms as per provisions in the regulations and ensure its strict compliance. Any violation of UGC regulations or if any institution fails to take adequate steps to prevent ragging or does not act in accordance with these regulations, if fails to punish perpetrates, of incidents of ragging suitably, UGC shall call for punitive actions against institutions.

3. All institutions are requested to step up anti-ragging mechanism by way of adequate publicity through various mediums, action-packed anti-ragging committee and anti ragging squad, quick-response system, CCTV cameras at vital points, alarm bells, regular interaction and counseling, identification on trouble-triggers, prominence to anti-ragging in the institution's prospectus and information booklets/brochures surprise inspection of hostels, students accommodation. Canteens, recreational rooms, toilets, bus-stands and any other measure which would augur well in preventing/quelling ragging and any uncalled for behavior/incident. The students and the parent/guardian community may also made aware of the anti-ragging helpline, anti-ragging website, anti-ragging monitoring agency and all constituent and affiliated colleges of the University should take necessary steps for its implementation under intimation to the Registrar, JNTUA, Ananthapuramu-515 002.
4. The student/parent ought to know whom to call and approach with alternative contact nos. when in difficulty. All the regulatory bodies and the educational institutions, including the universities funded by the UGC and the private universities, must ensure to UGC that they have a tight anti-ragging system.
